**HIGH COURT OF CHHATTISGARH, BILASPUR****CIRCULAR**No. **156 (Mis.)**
II-14-1/2026Bilaspur, date **08th** June, 2026

In supersession of the Circular No. 143 (Mis.) dated 19.05.2026 previously issued by the High Court of Chhattisgarh regarding direction of hearing of cases through Video-Conferencing, Car/vehicle pooling arrangement, work from home of Staff and sharing the official vehicle, the following fresh directions are issued to the extent as mentioned below for compliance **w.e.f. 15.06.2026:-**

1. The existing provisions, guidelines and facilities relating to hearing of cases through Video-Conferencing, as were in force prior to issuance of aforesaid circular in this High Court shall continue.
2. As the fuel supply situation has been considerably improved and the circumstances necessitating the temporary measures as issued by aforesaid circular, have largely been eased, all officers and employees shall continue to exercise due economy in the use of official vehicles and fuel, and every effort shall be made to avoid unnecessary movement and wastage of fuel.
3. In order to save the fuel, all the Judicial Officers and Ministerial Officers of this High Court as well as District Judiciary are requested to use/share their official vehicle with other officers of their office as a Vehicle Pooling to the extent possible.
